

Courts have consistently held that only the signature of the "party to be charged" is required. In other words, the contract must be signed by the party against whom enforcement is sought but does not necessarily have to be signed by the charging party.

Moreover, the promissory note is a negotiable instrument that **ONLY** needs to be signed by the maker (e.g. a check).
